Instructions for Use

- BEFORE USING THE PEN, READ ALL THE INSTRUCTIONS THOROUGHLY
- IT'S RECOMMENDABLE TO APPLY THE PRODUCT ON HIDDEN AREAS, WHICH DO NOT AFFECT THE COSMETIC APPEARANCE.
- THE FORENSIC PROPERTY PEN IS A TOOL TO MARK YOUR BELONGINGS, BEFORE ENTERING THEM IN THE HIGH-SECURITY DATABASE.
- IF YOU WISH TO DETER THIEVES, YOU MUST APPLY A STICKER ON AN ITEM AFTER MARKING IT.
- FOR LAW ENFORCEMENT PROTECTION YOU MUST REGISTER ALL MARKED ITEMS IN THE DATABASE

PRELIMINARY CONSIDERATIONS

- To avoid tempering, store your Forensic Property Pen in a secure place.
- The Forensic Property Pen should be stored in cool and dry spaces, at temperatures between 15 32°C.
- All areas of application must be free of dirt, grease, oil etc.
- Keep the lid of the Forensic Property Pen sealed, tightly when not in use.
- Allow a minimum of 1 hour dry time after application.

SURFACE PREPARATION

- The surface of the items must be cleaned and dried thoroughly, before applying the Forensic Property Pen.
- Once applied, the ink is permanent, therefore we advise you to carefully decide on the best spot to apply your marking.

<u>INSTALLATION</u>

- Shake the Forensic Property Pen to avoid any gaps in the application.
- Remove the lid from the top of the Forensic Property Pen
- Apply your unique PIN on the surface (your Pin is located on the outside on the lid of the box.)
- For extra security apply a warning sticker onto your marked item, warning potential thieves that the items are protected and traceable.

DRYING TIMES

- Dry to the touch in 1 hour depending on the weather (Adhesive dries clear)
- Do not wash marked areas for at least one week.
- Fully permanent after 2 to 3 weeks.

REGISTRATION

Now it's time to register your PIN in our website (<u>www.dnaprotected.com</u>). Registering your PIN helps LAW Enforcement identify the owners of stolen items, return them to their rightful owners, and help the police to detect thieves.
